Discussion:

The sub-committee revised the goals for city development to be included in the master plan. The goals are as follows:

- Promote a welcoming environment for commercial business & industry
- Encourage environmentally sensitive/context sensitive and sustainable development
- Encourage appropriate home sizing & massing
- Create lifelong neighborhoods of diverse housing for various income levels
- Improve street mobility, connectivity & safety
- Plan for vehicular needs, including parking
- Maintain and enhance the tree canopy

The sub-committee discussed the sub area plans. It was determined that there would be a vision for what was desirable for each area. The sub-committee spoke about broad land use categories and how the future land use map should not mimic current zoning classifications. They discussed potential city initiated rezoning, as appropriate.
